Eligibility

- Current pre-kindergarten educators
- Current K-12th grade teachers
- **NEW:** Available for professors at junior colleges

- Summary of program or project

 - ♦ Project outline
- Note: winners must provide an impact summary by May 1, 2026 for internal audit purposes

Evaluation

Applicants will be scored using this criteria:

- Creativity
- Number of students engaged
- Financial need (if applicable)
- **NEW:** Innovision Society will name one of these Grants after Belva Roberts and the project must relate to a civic activity or a teacher sponsoring a day of service for the class.

About Belva Roberts

Belva Roberts served on the Board of Directors from 1991 until her death in 2016. During her career, Belva was active in her community and in legislative advocacy.

Timeline

- Application period **EXTENDED:** Sept. 1 - **Oct. 20, 2025**
- Applications must be received by **Oct. 20, 2025**
- Winners will be notified by Dec. 5, 2025
- Grant funding will be awarded by mid-January 2026

No purchase necessary. Selection will be made without regard to applicant's race, color, ethnic origin, religious beliefs, sex, marital status, or physical ability.

Applications will be scored by the Innovision Society Grant Oversight Committee. Project summary and application must be submitted in English.

Applications must be received by October 20, 2025. Innovision Society teaching grant winners will be notified on or around December 5, 2025. Funds will be paid directly to the winner's school or school district on or around mid-January 2026. Winner must be able to provide a W9 from the winner's school or school district.

If winner is no longer employed at the school, the grant will then be awarded at the sole discretion of the Innovision Society Grant Oversight Committee based on the determination that the grant will be utilized for the purpose for which it was awarded and intended.

Each winner agrees to permit Innovision Society to use his/her name and likeness in promotional, other materials, or other third-party websites, without additional compensation or permission, except where prohibited by law. Winners will be asked to provide an impact summary by May 1, 2026.

Applicant agrees to accept the decisions of Innovision Society as final. Past Kinecta Innovision Society teaching grant winners, Kinecta and its subsidiaries' employees, volunteers, and their immediate family members are not eligible.
